ENG. 26/2003/14 : In exercise of the power conferred upon under Rule 25 (V) of Rules framed under the Water (Prevention and Control of Pollution) Act, 1974 as amended up to date and Rule 26 (3) of the Rules framed under Air (Prevention and Control of Pollution) Act, 1981 as amended, the Governor of Assam is pleased to enhance the fees structures of Consent to Establish and Consent to Operate and Renewal under the said Rules as stated below at (a) :

1. In continuation of the Public Notice which had been issued by the Board vide. No. WB/G-1271/21-22/19 dated 19.02.2022 pertaining to processing & other fees against which comments were invited from all stakeholders likely to be affected thereby, before the expiry of the period of fifteen(15) days from the date on which the said notification was made available to the public.

Now, in the greater interest of public and environment, the Pollution Control Board, Assam hereby prescribes the processing fees and penalties to be levied on industries / establishments / occupiers under purview of relevant statutes, details of which is available in the Board's website www.pcbassam.org/Notice.html

2. It is for general information that based on the Resolution of 103rd Board Meeting the 'Closure Notice' issued by the Board to 416 nos. of industries in the year 2019 have been hereby withdrawn. Environment Compensation Fine levied on 73 nos. of industries have also been waived off. The list of said industries/units is uploaded in the Board's website (www.pcbassam.org).
3. It has come to Board's Notice that a large number of illegal '**coal dumping yards**' have been set up along the Boko-Hahim road in Kamrup district without obtaining necessary consent, in violation of the Board's earlier order vide No. WB/LB-306/2017-18/334 dtd. 27.02.2020. All the coal depots are hereby directed to apply for Consent from the Board immediately in order to avoid penal action against them under the purview of existing environmental legislations.
4. The automobile workshops/garages release air pollutants, water pollutants into the environment and also generate Hazardous Waste in the form of spent oil (Schedule-I, category 5.1) and paint residue (Schedule-IV, Sl. No. 19). All the **automobile workshops** and the **independent garages** are therefore, directed to apply for Consent from the Board to avoid penal action against them under the purview of existing environmental law in force.

In pursuance to the decisions made in the 103rd Board Meeting, a Public Notice had been issued by the Board vide No. WB/G-1271/21-22/19 dated 19.02.2022 pertaining to processing fees and penalties, wherein comments were invited from all persons likely to be affected thereby, before the expiry of the period of fifteen(15) days from the date on which the said notification was made available to the public;

Now, therefore, after elapse of the stipulated time period, the Pollution Control Board, Assam hereby prescribe the following fees and penalties as stated hereunder.

1. Processing fees to be levied on applications for Authorization/Registration under Six (6) Waste management Rules.

2. Penalties to be levied on industries, which have failed to apply for Consent to Operate (CTO) within the stipulated period:

The industries are mandated to apply for renewal of Consent to Operate before its expiry. However, it is observed that many a times certain industries apply for CTO, after elapse of considerable period beyond its expiry, thus operating without having a valid CTO. Therefore, penalty provision for such defaulting industries is as stated below:

Sl. No.	Time period of delay in submission of CTO application	% of CTO fees to be levied as fine along with stipulated Consent fees
I	For applications submitted during the 1 st quarter (1 st April to 30 th June) of the financial year for which CTO is being sought.	25% of the CTO fees
II	For applications submitted during the 2 nd quarter (1 st July to 30 th September) of the financial year for which CTO is being sought.	50% of the CTO fees
III	For applications submitted during the 3 rd quarter (1 st October to 31 st December) of the financial year for which CTO is being sought.	75% of the CTO fees
IV	For applications submitted during the 4 th quarter (1 st January to 31 st March) of the financial year for which CTO is being sought.	100% of the CTO fees
V	For delay in submission of application beyond one year	Additional 100% for each year

Note: The authority in the Board has decided to waive off any penalty for the first Quarter of the F.Y. 2022-23 keeping it as a special window to give an opportunity to industries to regularize their Consents.

3. Fees to be levied for CTE Extension:

CTE Extension fee at 100% of the CTE fees as applicable to the projects at the time of CTE renewal shall be levied at the time submission of application for CTE application.

4. Enhancement of application fees for online processing of CTE/CTO in the OCMMS portal in lieu of the cost of application form.

Cost of application form charged prior to this notification.	Fee for online application
Rs. 100.00	Rs. 500.00

5. Environmental Compensation Fine to be levied on industries served with Closure/withdrawal of Consent or Authorization.

Minimum Environmental Compensation Fine at Rs. 5000/ day at par with NGT order in O.A.No. 593 of 2017 (Paryavaran Suraksha Samiti and Anr. Vs Union of India & Ors.) shall be levied on the defaulting units served with closure/withdrawal of consent or authorization from the day any such units is found violating with the prescribed environmental norms.

This notification shall come into effect from 01.04.2022 and will supersede all previous orders, if any, issued in this regard.

All the industries/occupiers / establishments under the purview of the aforesaid Rules which have been granted authorization prior to this notification and has a validity beyond 01.04.2022 shall have to pay the prescribed fee as arrear in their subsequent renewal of authorization or whenever asked by the Board.
